I am a scholar of English-language Literature and Cultural Studies with a focus on contemporary Anglophone literature and interdisciplinary approaches, especially from media studies and cultural theory. I received my PhD (Dr. phil.) in British literary and cultural studies from the University of Konstanz, Germany, in 2012, and my postdoctoral lecturer qualification (habilitation) from the University of Freiburg, Germany, in 2017. My research has focused on the representation of British Muslims in news media, fiction, autobiographies, film and governmental discourses, the prevalence of surveillance and relevance of surveillance camera images in news media, novels, film and media art, discourses of heroization in British television series, and futurity in fiction and narrative video games.

The project was broken into two subprojects: a) A corpus of popular 21st-century British television series was used to bring to light and analyse the heterogeneity of current figurations and semantics of heroism in British society. b) The project used the example of the series Doctor Who to study changes in such figurations since the 1960s. The accent in both subprojects was placed on interpretation of the televisual texts, which were examined with cultural discourses and formal aesthetic aspects of heroism in mind. I was co-PI of the project and supervised a PhD dissertation on Doctor Who which was completed in 2020.
